Extension of Last Date of Online Application Form of JEE (Main) April - 2020

In continuation to the Public Notice dated 7th February 2020 for submission of online application form of **JEE (Main) April – 2020** for admission to Undergraduate Programs in NITs, IIITs and other Centrally Funded Technical Institutions (CFTIs) etc. in the next academic year (2020-2021), it is hereby informed that the last date for submission of online application form, is extended from **6th March 2020 to 12th March 2020**, in order to enable the aspiring candidates who have not been able to apply in the Online Application Form. This is being done in view of a number of requests being received in this regard.

All the registered candidates of **JEE (Main) January / April-2020** note that the facility for correction in their data (**except choice of cities**) will be operational on the website: jeemain.nta.nic.in from **13/03/2020 to 16/03/2020 (up to 11.50 p.m.)**.

Since, it is a onetime facility extended to the candidates to avoid any hardship to them, the candidates are informed to undertake the correction(s) very carefully as no further chance will be given.
